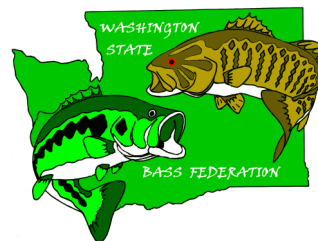

Adult Tournament Rules

Please Read Carefully

Interpretation of these rules shall be left exclusively with the Tournament Committee. The decision of the Tournament Director shall be final and non-contestable in all matters.

1. Participation and Eligibility: Participation in this tournament is limited to members in good standing of the Washington State Bass Federation and guests. A properly completed and signed registration form must be received by the tournament officials prior to competitively fishing tournament waters.

2. Pre-Tournament Practice, Hours, and Schedule of Events: Tournament waters shall be open to all participants at all times. However, only fish caught during tournament hours will be weighed and scored for competition. Tournament hours for each day, not to exceed 16 hours total competition time, will be designated in the Schedule of Events. It is the responsibility of each competitor to be acquainted with the Schedule of Events. A Schedule of Events will be given to each competitor at registration.

3. Registration: Each competitor must register during Open Registration times and places as listed in the Schedule of Events. Competitors may register after registration closes by appointment with tournament officials. Every competitor **MUST** register before entering tournament waters for competition.

4. Safety: Safe boating conduct must be observed at all times, by all competitors. Boat drivers **MUST** be connected to the kill switch, and driver and all passengers **MUST** wear a Coast Guard Approved Type 1, 2, or 3 Personal Flotation Device, any time the combustion engine is running and in gear. Violation of these rules shall be reason for disqualification.

5. Sportsmanship: Competitors are expected to follow high standards of safety, sportsmanship, courtesy and conservation. **NO ALCOHOLIC** beverages will be allowed in competitor boats during tournament hours, or in designated weigh-in area. Drunkenness by any competitor during tournament hours will not be tolerated and shall be cause for disqualification.

6. Tackle and Equipment: Only artificial lures may be used. No live or prepared bait will be permitted with the exception of pork rind. All bass must be caught live and in a conventional sporting manner.

7. Basic Boat Equipment: Every boat must have all required Coast Guard safety equipment. In addition, competitor boats must have: a kill switch, and a functional live well space, properly aerated to adequately maintain a limit catch of bass for each angler using the boat. The Tournament Director shall have sole responsibility for determination of "adequate".

8. Boat Inspection: Each boat must pass an inspection, prior to the first day's start. Competitors and their boats shall be in full conformance with all rules at all times. It is each competitor's responsibility to have his/her boat inspected by a tournament official prior to entering tournament waters for competition. Catches made from an uninspected boat are ineligible for weigh-in.

9. Boat Operation and Expenses: Boat owners and their partners will be expected to work out their own arrangements on boat operation and expenses. If a boat becomes disabled during the tournament day, it may be exchanged, but the replacement boat must be inspected by tournament officials prior to its use in the tournament.

10. Permitted Fishing Locations: Fishing on tournament waters is permitted anywhere accessible by boat from the official checkpoint, except within 100 feet of a refueling dock or 100 feet of a competitor's boat which was first anchored. No such anchored boat shall permit selected competitors to fish within the 100-foot circle at the exclusion of any other competitor. Other restricted waters will be announced at the drivers meeting. All angling must be done from a boat. Contestants may not depart boat to land fish. All contestants must return to official checkpoint by boat for the day's catch to be eligible for weigh-in.

11. Official Checkpoint: There shall be one official checkpoint for check-in/check-out. Exact starting and check-in times will be listed in the Schedule of Events.

12. Penalties: Competitors who are not in the official checkpoint area at the appointed time, shall be penalized at the rate of 16 ounces/minute, to be deducted from his/her day's total weight. Any competitor more than 15 minutes late will not be allowed to weigh-in. After checking in, competitors will be allowed ample time to proceed to the scales. Other penalties are as follows: 16 ounces for fish failing to meet the minimum length requirement, 8 ounces per dead/dying fish; frozen, stringered, mutilated, or otherwise altered fish will not be weighed.

13. Scoring: The individual limit shall be five bass. Only fish 12 inches or longer (mouth closed, tail tilted, on a flat board) will qualify for weigh-in. Each competitor must keep his/her catch separate from his/her partners, and **MUST** present his/her own catch to the Weigh Master. Every effort must be made to keep the bass alive, and all live and uninjured bass will be released.

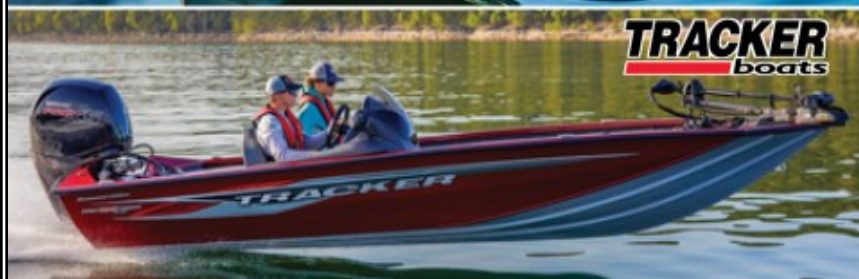
14. Cell Phones/Radios: the use of cell phones or radios for the purpose of contacting a fellow teammate is strictly prohibited and **WILL** result in disqualification.

15. Club Team Scoring: Will be determined by the number of registered contestants of that club, less penalties. In no case shall the divisor be less than 10. Individual winners will be determined by the highest total weight, less penalties. In case of ties, the club or individual weighing the largest bass will be declared the winner.

16. Disqualification: All contestants are bound by prevailing statutes and regulations of the Department of Wildlife. Violation of ANY state law, or WDFW regulation **WILL** result in disqualification.

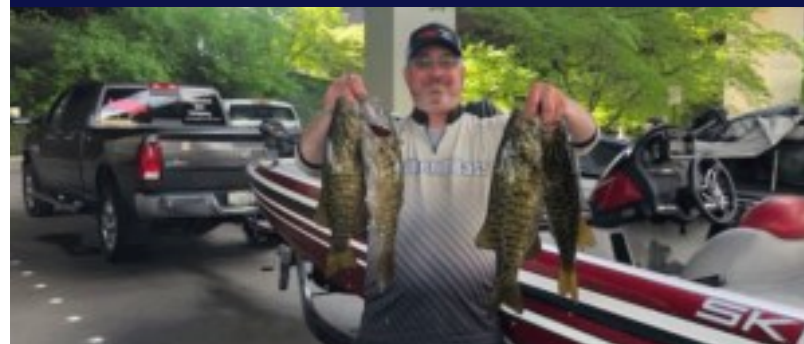

All Live fish must be returned to the lake. Only dead fish may be kept.

Prizes:

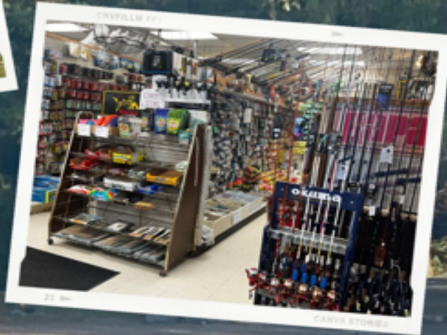
First, second and third place trophies will be awarded in each age group.

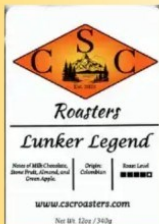

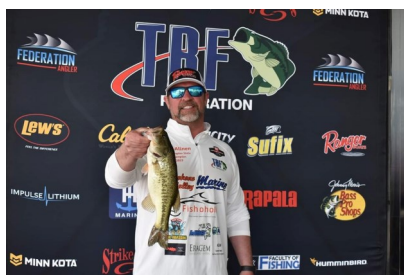

Highlights of the new TBF National Semi Final Format

- All National Semi-Final events will take place in two and three state groups, so travel will only be “next door”. This means not only are travel costs greatly reduced and payouts greatly increased but the new program will host a National Semi Final event in every market segment of North America.
- Anglers want to fish for prize money. The new entry fee structure will allow payouts at the Individual, State, and National levels.
- This program greatly reduces the amount of time required to qualify and advance to the National Championship, now only one calendar year.
- In a new club benefit for every TBF affiliated club in good standing with their state, they will have the ability to qualify their top anglers direct from their club to a TBF National Semi-Final.
- Larger membership states will qualify more anglers to a National Semi Final because they have more members competing. Each state federation will send a minimum of 12 anglers to a National Semi Final, there is no maximum based on membership participation and growth.
- MORE anglers from each state will also advance to the TBF Federation National Championship. For instance at the 2022 Federation National Championship at least 2 boaters and 2 co-anglers from each state. Depending on participation numbers, some states may advance even MORE.
- State Pride. The program will contain a new “State vs State Competition” piece within each National Semi-Final where a percentage of top qualifying anglers will represent their home state with significant prizes and bragging rights for the state who wins their National Semi Final.
- All payouts will increase significantly across the board however a major emphasis and rewards are being added for those members qualifying as a co-angler in each National Semi Final and in the Federation National Championship.
